TRUSTEE'S REPORT ON THE STATE OF THE INSOLVENT PERSON'S BUSINESS AND FINANCIAL AFFAIRS

(Pursuant to Sections 50.4(7)(b)(ii) and 50.4(9) of the Bankruptcy and Insolvency Act)

I, Philip Manel, CPA, CA, CIRP, of Richter Advisory Group Inc. ("Richter"), Trustee, with respect to the Notice of Intention to Make a Proposal ("Notice of Intention") filed by 161617 Canada Inc. (the "Company" or "Debtor"), an insolvent person, do hereby report to the Court the following:

- 1. On October 10, 2014, the Debtor filed a Notice of Intention in accordance with the *Bankruptcy and Insolvency Act* (the "Act"), a copy of which is annexed hereto as **Exhibit "A"**.
- On October 16, 2014, documents were sent by regular mail to all creditors of the Debtor, as identified by it, which included a copy of the Debtor's Notice of Intention, as annexed hereto as Exhibit "B".
- 3. On October 16, 2014, the Debtor filed with the Official Receiver a Statement of Projected Cash Flow ("Projections") together with his report pursuant to Section 50.4(2)(c) of the Act, covering the period from October 11, 2014 to November 7, 2014, which included the major Assumptions used in the preparation of the aforenoted Projections. Concurrently therewith, the Trustee filed its Report on the reasonableness of the Projections in accordance with Section 50.4(2)(b) of the Act, all of which is annexed hereto as Exhibit "C".
- In order to monitor the affairs and finances of the Debtor, the Trustee has been provided with access to the books, records and other important documents of the Debtor.

- 5. The Debtor has been paying its suppliers and employees, on a timely basis, for goods and services provided subsequent to the date of the filing of the Notice of Intention, according to the current business terms. The Trustee has compared the actual results to those projected since the filing of the Notice of Intention. The actual results to date have been favorable.
- 6. The Company, in operation since 1988, is engaged in the distribution of horticultural products, in Quebec and eastern Ontario.
- 7. At the time of the filling, the Company had over 14 employees working at its head office and warehouse.
- 8. In the past two years, the Company has experienced a significant decline of its sales and reported significant losses. Management attributes this decline in sales to the following:
 - · Current unfavorable economic conditions in the golf industry;
 - Insufficient funding of its operations; and
 - General economic downturn.
- 9. Pursuant to the assessment of its financial situation, Management began implementing, in early 2014, certain corrective measures, with the intent of ensuring its long-term profitability. However, in July 2014, the Company lost the support of its main supplier of irrigation equipment. This event further aggravated the decline of its sales, necessitating a formal restructuring through a Notice of Intention.
- 10. Pursuant to the filing of the Notice of Intention, the Company has been developing and implementing its restructuring plan. The key elements of this plan include:
 - The liquidation of its slow-moving and excess inventory;
 - The reduction of operating and overhead expenses;
 - The search for potential investors and/or acquirers who could participate in the restructuring. The Debtor is currently in talks with one potential acquirer who could participate in the financing of a Proposal; and
 - The determination of the terms of a viable proposal to its unsecured creditors.
- 11. The Debtor is filing a Motion to Extend the Delay for the Filing of a Proposal, in order to allow it to complete its dealings with regards to the above-mentioned key elements and to enable the formulation of a viable proposal to its creditors.
- 12. The Debtor's secured creditor, Accord Financial, does not object to the requested extension and supports the Debtor in its reorganization efforts.
- Annexed hereto as Exhibit "D" is the Statement of Projected Cash Flow covering the period from November 3 to December 22, 2014, the Trustee's Report on the reasonableness of the Projections in accordance with Section 50.4(2)(b) of the Act and the Debtor's Report pursuant to Section 50.4(2)(c) of the Act.

- 14. If the extension is granted, the Trustee is not aware of any facts indicating that any creditor would suffer a prejudice.
- 15. Given the foregoing, the Trustee hereby recommends the granting of the extension by the Court to December 22, 2014.
