Take notice that:

- 1. On February 9, 2016, pursuant to an order (the "Initial Order") granted by the Ontario Superior Court of Justice (Commercial List) (the "Court"), GuestLogix Inc. was granted protection pursuant to the Companies' Creditors Arrangement Act (the "CCAA"). The proceedings commenced by GuestLogix Inc. under the CCAA are referred to herein as the "CCAA Proceedings". The Initial Order was amended on February 12, 2016 to include GuestLogix Ireland Limited in the CCAA Proceedings.
- 2. On September 12, 2016, the Court granted an order (the "Plan Sanction Order") sanctioning the Plan of Compromise or Arrangement of GuestLogix Inc. dated July 29, 2016, as amended (the "Plan"), pursuant to the CCAA.
- 3. On September 21, 2016, in accordance with the Plan Sanction Order, the Plan was implemented, the CCAA Proceedings in respect of GuestLogix Inc. were terminated and 2537330 Ontario Inc. ("253" or the "Company") was included as an applicant in the CCAA Proceedings.
- 4. Under the terms of the Plan, GuestLogix Inc. transferred certain of its assets that the Plan Sponsor (as defined in the Plan) did not want to retain to 253 together with any and all encumbrances in respect of such assets. The approved Plan contemplated the immediate dissolution and liquidation of 253 and, on September 26, 2016, the Court issued an order which, among other things, authorized 253 to make an assignment in bankruptcy.
- 5. On September 27, 2016, 253 filed an assignment in bankruptcy, and the undersigned, Richter Advisory Group Inc., was appointed as trustee of the estate of the bankrupt by the official receiver, subject to affirmation by creditors of the trustee's appointment or substitution of another trustee by creditors.

- 6. The first meeting of creditors of the bankrupt will be held on October 17, 2016 at 2:00 PM, at the trustee's office, located at 181 Bay Street, 33rd Floor, Toronto, ON M5J 2T3.
- 7. To be entitled to vote at the meeting, a creditor must file with the trustee, before the meeting, a proof of claim and, where necessary, a proxy.
- 8. Enclosed with this notice are a proof of claim form, proxy and list of creditors with claims amounting to \$25 or more showing the amounts of their claims. The claim amounts shown represent estimated residual claims against 253 after taking into account proposed distributions to creditors pursuant to the Plan.
- 9. Creditors must prove their claims against the estate of the bankrupt to share in distributions, if any, of the proceeds realized from the estate.
