Notice and Statement of the Receiver

(Subsections 245(1) and 246(1) of the Act)

Further to the Ontario Superior Court order (the "Order") rendered on July 31, 2024, Richter Inc. ("Richter"), was appointed as receiver (the "Receiver"), without security, of all the assets, undertakings and properties of Britman Specialty Products Inc. (the "Company" or "Debtor") pursuant to Section 243 of the *Bankruptcy and Insolvency Act* and section 101 of the *Courts of Justice Act*.

Richter, in its capacity as Receiver, gives notice and declares that:

- 1. On the 31st day of July 2024, Richter became the Receiver in respect of the property of Britman Specialty Products Inc. described below:
 - (a) Accounts receivable and inventory values as reported on the Borrowing Base calculation dated July 23, 2024;
 - (b) For the other assets, the value reported on the Debtor's most recent internal, unaudited financial statements, as of December 31, 2023:
