Notice and Statement of the Receiver (Subsections 245(1) and 246(1) of the Act)

In the Matter of the Receivership of La Cité Médicale Inc. of the City of Montréal In the Province of Québec

Further to the Order of the Quebec Superior Court (the "Order") rendered on December 23, 2024, Richter Inc. ("Richter") was appointed as receiver (the "Receiver") pursuant to Section 243 of the Bankruptcy and Insolvency Act in respect of the property of La Cité Médicale Inc., (the "Debtor" or the "Company"), as described below:

"Act as receiver of the Debtor's movable property, tangible and intangible, present and future, whatever they may be, of any nature whatsoever, in any place and in any hands whatsoever....". ("Property")

The Receiver gives notice and declares that:

- 1. Richter was appointed Receiver pursuant to the Order, following an application filed by Fiera Enhanced Private Debt Fund LP ("**Fiera**").
- 2. The following information relates to the receivership:
 - (a) Legal address of Debtor: 5990, ch. de la Côte-des-Neiges, Montreal, Qc H3S 1Z5
 - (b) Principal line of business: Operator of 2 medical clinics in the Québec City region, offering family medicine, specialized medicine and various private services.
 - (c) Locations of clinics:
 - i. Place de la Cité, 2nd floor, 2600, Laurier boulevard, Suite 295, Québec Qc G1V 4T3
 - Carrefour Charlesbourg, 2nd floor, 8500 Henri-Bourassa Blvd., Suite 250, Québec Qc G1G 5X1
 - (d) The book value of the assets as per the Debtor's internal, unaudited financial statements, as of October 31, 2024, are described below:

- (e) Amount owed by the Debtor to each creditor who holds a security on the Property described above (subject to Receiver's review):
 - Fiera \$7,780,394

The list of other creditors of the Debtor and the amount owed to each creditor, totaling \$122,676, is attached as Schedule "A". The total due to creditors amounts to approximately \$7,903,070.

- (f) At the time of the receivership, the clinics were operating in the normal course.
- (g) Fiera, the first ranking secured lender of the Debtor, through its affiliated company, Fiera FP Business Financing Fund, L.P. ("Interim Lender"), will provide a \$1.25 million credit facility ("Interim Financing Facility") during the receivership proceedings, to fund the working capital needs and restructuring costs of the Debtor. The Interim Financing Facility is subject to a \$1.5 million charge over the Property in favour of the Interim Lender.
- (h) The estimated realization value of the Company's business and / or Property is currently unknown. The intended plan of action of the Receiver during the receivership is to, in accordance with the Order:
 - Ensure the continued service and care to patients by stabilizing the liquidity needs of the Company, and ensure that its doctors, healthcare professionals and employees continue to be paid;
 - Take all necessary action to safeguard the Debtor's Property; and
 - Initiate and proceed with a sale solicitation process of the Debtor's business and / or Property.

In connection with the plan of action, the services being rendered by the Debtor are continuing in the normal course of business and no changes to the operations are contemplated.

- 3. The Order authorizes the Receiver to exercise, without having any obligations to do so, the following powers, including, but not limited to:
 - Take possession of all of the Debtor's Property;
 - Continue, in whole or in part, the operations and activities of the Debtor;
 - Control receipts and disbursements of the Debtor;
 - Negotiate and execute the Interim Financing Facility on behalf of the Debtor; and
 - Solicit potential purchaser(s) in the Debtor's business or the Property, in whole or in part, including, without limitation, the right to conduct a public tender or private solicitation for the disposition of the Property.
