

Notice of objection to the discharge, setting out the reasons for opposition, must be filed with the registrar, at the Court House, Québec Superior Court – Montréal, 1 Notre-Dame Street East, Room 1.146, Montréal, QC H2Y 1B6 at least five days before the date of the hearing, and a copy of the notice must be served on us within those five days.

("TSG" or the "Company" or the "Debtor") was declared bankrupt following an Order rendered by Me Chantal Fiamand, registrar of the Quebec Superior Court pursuant to Section 43 to the Bankruptcy and Insolvency Act ("BIA") and Richter Advisory Group Inc. (formerly RSM Richter Inc.) was appointed trustee to the Bankruptcy ("Richter" or the "Trustee").

An Estate number was opened by the OSB for the Petition for Receiving Order and following the Order rendered, Estate number 41-342594 was issued by the OSB for the Bankruptcy Order.
